BOARD MEETING
MAY 21, 2020
MINUTES**

The New Mexico Junior College Board met on Thursday, May 21, 2020, beginning at 1:42 p.m. in the Zia Room of Pannell Library and via Zoom. Madam Chair Pat Chappelle, in attendance in the NMJC Zia Boardroom, requested Board members attending via Zoom note their attendance by roll call. The following members were in attendance: Ms. Patricia Chappelle, Madam Chair; Mr. Ron Black, Secretary; Mr. Travis Glenn; Mrs. Erica Jones; Ms. Evelyn Rising; and Mr. Hector Baeza. Mr. Manny Gomez was absent. Also in attendance via Zoom were Dr. Kelvin Sharp, Dr. Larry Sanderson, Mr. Dan Hardin, Mr. Scotty Holloman, Mrs. Cathy Mitchell and Mr. Jeff McCool.

Ms. Chappelle called the meeting to order and welcomed everyone attending via livestream due to the current COVID-19 pandemic and the current Public Health Order requiring social distancing. She stated time-sensitive issues must continue to be addressed therefore, NMJC will continue to follow the guidance of the New Mexico Attorney General's Office issued on March 17, 2020 by holding this virtual meeting. Ms. Chappelle encouraged the public to participate and provide public comments at the end of the formal agenda to either (575) 392-5004, fax (575) 492-2764 or by email to ksharp@nmjc.edu.

Upon a motion by Mr. Glenn, seconded by Mr. Black, and by roll call vote as follows: Mr. Baeza – yes, Ms. Rising - yes, Mr. Black - yes, Mrs. Jones – yes, Mr. Glenn – yes and Ms. Chappelle – yes, the agenda was unanimously adopted.

Upon a motion by Ms. Rising, seconded by Mr. Black, and by roll call vote as follows: Mr. Baeza – yes, Ms. Rising - yes, Mr. Black - yes, Mrs. Jones – yes, Mr. Glenn – yes and Ms. Chappelle – yes, the Board unanimously approved the minutes of April 16, 2020.

Under President's Report, Dr. Sharp stated NMJC is waiting for official documentation from the governor's office outlining the phases for the reopening of the NMJC campus. He stated the President's Report will share how NMJC has been presented to the NMJC students during the closure, what faculty is anticipating and what customers from Training & Outreach are asking. Dr. Sharp and the Board acknowledged the NMJC staff and faculty for their unrelenting dedication and efforts to assure student success during challenging times.

Mrs. Cathy Mitchell, Vice President for Student Services, provided updates for the Student Services Department. Mrs. Mitchell reported the resilient and flexible staff in Student Services continue to assist students register for classes. Advisement for students has been done virtual, through email, and by phone. Calls to the help desk are disbursed daily to advisors. Enrollment numbers for fall are right on track and staff is currently working on plans for an online orientation. Mail out of graduation packets with diplomas, covers and other goods are in progress. Testing Center is closed with face to face testing for the Nursing Program only with a limit of four testing at one time. Mrs. Mitchell further noted online testing opportunities are also available. The Financial Aid staff have continued to work on FASFA and Financial Aid. Mr. Black asked for status of the international students and if there is a plan for the fall semester. Mrs. Mitchell responded there are currently approximately 25 international students in the dorms that were not able to go home and noted food services has continued to be provided. The contingency plan for fall is to continue with social distancing by spreading students out so multiple students are not in bedrooms/apartments. She commented all decisions made going forward will be dependent on directions from the governor's office.

Mr. Jeff McCool, Vice President for Training & Outreach provided updates for the Training & Outreach Department (T&O). He reported with the closure of the campus, the biggest challenge has been communication with regards to status of schedules and classes. He noted T&O has continued to work on efforts to keep constituents apprised of what is going on. Transportation Department has been handling various calls from individuals dealing with upcoming expiration deadlines on DWI classes, motor vehicle permits, testing, and getting licensed. Training curriculum is being updated and SBDC has been busy with the Paycheck

Protection Program, different loans through emergency opportunities and assisting the local community.

Dr. Larry Sanderson, Vice President for Instruction provided updates. He reported with the sudden shift in the spring semester to all online classes, over 20 faculty members moved forward with successful online classes while many had never taught online before. He stated the number one goal was to get students through in good order as was done last spring. He reported grade distributions and the number of students who passed in spring 2020 compared to spring 2019 were very similar with 2% fewer withdrawals. Summer 2020 will offer online classes only with current enrollment at approximately 75% of last summer. Dr. Sanderson noted the goal in August, subject to adhered health orders, is to open all forms of classes, face to face, online, and ITV, with backup plans in place in the event it is not possible. Current discussions are the number of Nursing Program students that will be admitted into cohorts this fall with the issue of no current clinical sites in New Mexico. Given that outside instructors are brought in for the Law Enforcement Academies, the current academy was placed on hold and are waiting to finish. Mr. Glenn asked how placement in the fall semester will be affected with high school seniors not able to test. Dr. Sanderson responded a two-year research of placement policies pointed to the fact that placement in English and math classes, using one measure, is a high school GPA. Due to the results of the research, a new placement policy has been implemented for classes beginning in the fall. Students who tested and produce scores will continue to be accepted but high school transcripts and GPA's will now be used to place students without the testing. Mr. Glenn commented some high schools have moved to a pass/fail system affecting the evaluation of GPA's. Dr. Sanderson noted various schools, staying with grades, requested NMJC also stay with grades. Dr. Sanderson stated students should be graded for their efforts and therefore NMJC finished the year with grades for all students to include the dual credit high school students.

Under New Business, Dr. Sharp commented NMJC has had Federal Grant opportunities such as the CARES ACT for students/institution and the FEMA Grant. Dr. Sharp expressed his appreciation to Mr. Dan Hardin and staff for their efforts in steering NMJC through the grants as well as managing all of the required HED and DFA reporting, specifically due to the drop in funding and drop in oil

and gas revenue in the State of New Mexico. Mr. Dan Hardin presented the April 2020 financial reports. Upon a motion by Mr. Glenn, seconded by Mr. Baeza, and by roll call vote as follows: Mr. Baeza – yes, Ms. Rising - yes, Mr. Black - yes, Mrs. Jones – yes, Mr. Glenn – yes and Ms. Chappelle – yes, the Board unanimously approved the Expenditure Report for April 2020. In addition, the Revenue Report, Oil and Gas Revenue Report, and Schedule of Investments Report were reviewed.

Mr. Hardin presented consideration of the Five-Year Capital Plan to be submitted to the Higher Education Department with NMJC's top two priority projects. Administration recommended the number one project be Safety & Security for funds to help with the construction of vestibules at various buildings on campus, sidewalk repairs, tunnel repairs and shading structures. The recommended number two project is the Vocational B HVAC for the installation of an air handler to the Don Whitaker Building currently not on the Central Plant. Installation will give the Central Plant control of cooling and heating to the Vocational B Building and will allow the growth of the Diesel Program. Mr. Glenn asked if this area of the building currently has heating/cooling. Mr. Hardin responded there is currently swamp coolers & heating and noted installation to tie to the Central Plant will allow for better heating and cooling. Upon a motion by Ms. Rising, seconded by Mr. Glenn, and by roll call vote as follows: Mr. Baeza – yes, Ms. Rising - yes, Mr. Black - yes, Mrs. Jones – yes, Mr. Glenn – yes and Ms. Chappelle – yes, the Board unanimously approved the Five-Year Capital Plan as presented.

Dr. Sharp presented the annual Board Policy Manual Revisions for Policies No. 704 and No. 806 for approval. Mrs. Mitchell provided discussion of revisions to Policy No. 704, Student Services, Code of Conduct. After review of revisions to Policy No. 704, Mr. Glenn recommended an amendment to insert the word “impartial” as follows: J. Student Disciplinary Committee, 1. “The Student Disciplinary Committee consists of three (3) impartial members of the campus community including a Chairperson”. Upon a motion by Mr. Glenn, seconded by Mrs. Jones, and by roll call vote as follows: Mr. Baeza – yes, Ms. Rising - yes, Mr. Black - yes, Mrs. Jones – yes, Mr. Glenn – yes and Ms. Chappelle – yes, the Board unanimously approved Policy No. 704 revisions with the recommended amendment. Mr. Dan Hardin provided discussion of revision to Policy No. 806,

Fiscal and Support Services, Cash Management. After review of revision to Policy No. 806 and upon a motion by Mr. Black, seconded by Ms. Rising, and by roll call vote as follows: Mr. Baeza – yes, Ms. Rising - yes, Mr. Black - yes, Mrs. Jones – yes, Mr. Glenn – yes and Ms. Chappelle – yes, the Board unanimously approved Policy No. 806 as presented.

Mr. Scotty Holloman presented a consideration for Continuation of Pay of Hourly Employees/CARES Act Funds. Mr. Holloman requested an extension of the amended Temporary Compensation & Benefits: Leaves & Absences Policy adopted at the April Board Meeting effective from April 1, 2020 to May 30, 2020. This request will extend the policy to June 30, 2020. The policy allows for employees to be paid regular wages during the closure of the NMJC campus in accordance with the New Mexico Health Orders. Administration recommended the use of the CARES Act funding to pay wages for full-time support staff employees through June 30, 2020. Upon a motion by Mr. Black, seconded by Ms. Rising, and by roll call vote as follows: Mr. Baeza – yes, Ms. Rising - yes, Mr. Black - yes, Mrs. Jones – yes, Mr. Glenn – yes and Ms. Chappelle – yes, the Board unanimously approved this request as presented.

Ms. Chappelle called for comments from the public. There being none, the next regular board meeting was scheduled for Thursday, June 25, 2020 beginning at 1:30 pm.

Upon a motion by Mr. Glenn, seconded by Mr. Baeza, and by roll call vote as follows: Mr. Baeza – yes, Ms. Rising - yes, Mr. Black - yes, Mrs. Jones – yes, Mr. Glenn – yes and Ms. Chappelle – yes, the board meeting adjourned at 3:00 pm.

RE: Expenditure and Revenue Reports for May 2020

The total year-to-date funds expended and/or encumbered through the month of May is \$48,921,619.00.

The total current unrestricted fund expenditures through May are \$25,774,727.00, which is 83% of the budget. The expenditures in Instruction and General through May are \$19,921,033.00, which is 79% of the budget. Total Current Unrestricted Fund expenditures are slightly higher than at this time in FY 19. This is due to the salary increase for FY 20.

Restricted funds for the year are \$4,848,822.00. The Grants are doing a good job of staying on track with their spending and reporting. Financial Aid has been working closely with the Business Office to get all awards completed and funds drawn.

Plant funds are showing \$18,298,070.00 in total expenditures and encumbrances through the month of May. You are seeing the expenditures for the Fire Alarm project, McLean Hall renovation, the construction of the Law Academy building, Technology Upgrade, and the beginning of the Caster Upgrade project.

Total year-to-date expenditures through May 2020 are \$48,921,619.00.

Total Revenue through May 2020 is \$49,175,106.00. Total Unrestricted revenue at the end of May was \$42,296,672. We are expecting another large property tax distribution from the Lea County Treasurer in June. Auxiliary income, which is the Bookstore, Housing, and Food Service is up as compared to this time in FY 19.

Restricted fund revenue through May is 4,818,823.00. The Business Office will draw down as much funds as possible by the end of June.

Total revenue at the end of May including Plant fund revenue is \$49,175,106.

The College received \$2,031,212 in Oil and Gas revenue in May, which was for the

month of February. There will be four more months of Oil and Gas revenue to receive that will be posted in the FY 20 fiscal year.

As of the end of May, NMJC has \$40,593,127.00 in the LGIP fund, \$3,000,000.00 in CDAR's and there are \$37,909,926.20 in designated capital projects.

This concludes the Financial Report for May 2020.
