

**NEW MEXICO JUNIOR COLLEGE  
BOARD MEETING  
NOVEMBER 17, 2016  
MINUTES**

The New Mexico Junior College Board met on Thursday, November 17, 2016, beginning at 1:30 p.m. in the Zia Room of Pannell Library. The following members were present: Ms. Patricia Chappelle, Madam Chair; Mr. Ron Black, Secretary; Mr. Travis Glenn; Mrs. Mary Lou Vinson; Mr. Zeak Williams; and Mr. Hector Baeza. Mr. Manny Gomez was absent.

Ms. Chappelle called the meeting to order and welcomed visitors and guests present.

Upon a motion by Mr. Glenn, seconded by Mrs. Vinson, the agenda was unanimously adopted.

Upon a motion by Mr. Williams, seconded by Mr. Glenn, the Board unanimously approved the minutes of October 20, 2016.

*Under President's Report*, Mr. Deron Clark, Director of Athletics, announced the following two new alumni have joined the Western Junior College Athletic Conference Hall of Fame. Mr. Brad Winter, a 1972 graduate and a previous member of the NMJC track team now serving as the Secretary of State for New Mexico. Mr. Clark stated Mr. Winter will return in the spring of 2017 to be a guest speaker at the NMJC Athletics Banquet. Mr. Ray Birmingham, a longtime baseball coach and currently the head coach at University of New Mexico. Mr. Birmingham will be inducted and recognized in January, 2017 at an NMJC basketball game during the half time ceremony. Mr. Clark stated dates for both events will be provided when available.

Coach James Berry provided a recap of the golf team for the fall semester. He reported out of six tournaments, NMJC finished in the top three five times. He stated NMJC had two 2nd places finishes and one team championship in Waco.

Currently, NMJC has three players ranked in the top 18 in the country and four in the top 50. He reported NMJC is currently ranked #7 in the country. Coach Berry introduced student Mike Garcia noting Mr. Garcia is not only a talented athlete but also a good student with a GPA of 3.7.

Coach Keith Blackwill introduced three student athletes who competed in the National Cross Country meet last week. Ms. Cynthia Kipserem from Kenya placed 75<sup>th</sup>. Ms. Cassidy Reddell from Odessa, Texas placed 114<sup>th</sup> and stated she has recently signed to run cross country for the University of Texas Permian Basin. Ms. Teresha Jacobs from Jamaica placed 33<sup>rd</sup> earning a NJCAA Coaches Association All American Honors. In addition, Coach Blackwill reported three additional NMJC student athletes have signed Division I, National Letters of Intent. Kayelle Clark and Christine Moss have signed with the University of Kentucky and Tamara Moncrieffe has signed with the University of Alabama.

Coach Marty Eakin thanked the Board for the support given to the Rodeo Program and reported the NMJC men's team is currently in 3rd place with hopes they will make it to Nationals. Coach Eakin introduced student athlete Preston Burr from Stratford, Texas who is placing in the team roping and currently winning the region in the saddle bronc riding.

Dr. Darrell Beauchamp reported during the 104 day run of the Titanic Exhibition, WHM had 35,362 visitors far exceeding the goal of 28,000. He reported actual tours of the exhibition were closer to 40,000 stating many of the visitors went through the exhibition multiple times during one visit. Visitors signed in from 337 hometowns, 41 states, and 11 countries. Merchandise sales totaled \$203,453, admissions to the museum totaled \$48,000, at register donations were over \$13,653 and memberships were over \$15,000. WHM had approximately 8,000 students from 9 high schools, 5 middle schools, and 19 elementary schools. He stated fundraising totals are expected to reach close to \$500,000. Dr. Beauchamp reported more than 100 people logged approximately 1,000 volunteer hours during the exhibition and expressed his appreciation to all who participated in making the exhibition a success. Dr. Sharp and the Board also thanked all volunteers for the hours invested in the exhibition.

Dr. Larry Sanderson provided an overview of an electronic survey distributed to the NMJC campus and community members asking for their opinion of NMJC's current Mission and Vision Statement. He reported the survey reflected the current Mission and Vision Statement serves New Mexico Junior College as is with no changes. The Board unanimously agreed.

Dr. Sharp announced Bond C was passed on November 8<sup>th</sup>. Dr. Sharp thanked Mrs. Susan Fine for all her efforts and work on advertising, creating of brochures, and organizing presentations made throughout the community. In addition, Dr. Sharp thanked everyone who made presentations and congratulated all who were involved in the success of this project.

Dr. Sharp shared that Mr. Dale Gannaway and New Horizons Foundation hosted a group from the Armament Research Development and Engineering Center this week and reported on Tuesday, November 15<sup>th</sup>, NHF was given a Resolution signed by the Lieutenant Governor John Sanchez of the State of New Mexico. NHF was recognized as an important partner in the mission to develop New Mexico's rural economy. Dr. Sharp stated Mr. Gannaway will provide more details in a Board meeting in the near future.

*Under New Business*, Mr. Dan Hardin presented the October, 2016 financial reports. Upon a motion by Mr. Glenn, seconded by Mr. Baeza, the Board unanimously approved the Expenditure Report for October, 2016. In addition, the Revenue Report, Oil and Gas Revenue Report, and Schedule of Investments Report were reviewed.

Mr. Dan Hardin presented the state mandated Quarterly Financial Action Report. After discussion and upon a motion by Mr. Glenn, seconded by Mr. Black, the Board unanimously approved the Quarterly Financial Action Report.

Mr. Dan Hardin presented a Budget Adjustment Request for approval. With the passing of Bond C approving \$4,000,000 GOB funds for the NMJC Allied Health Building, Administration is requesting approval to transfer \$1,500,000 from the I&G fund balance to the Allied Health Building Construction Fund. Upon a

motion by Mr. Glenn, seconded by Mrs. Vinson, the Board unanimously approved this request.

Ms. Chappelle called for comments from the public. There being none, the next regular board meeting was scheduled for Thursday, December 15, 2016 beginning at 3:30 pm. In addition, a Board Training was scheduled for Friday, December 9, 2016 beginning at 8:00 am at the Hilton Garden Inn's conference room.

Mr. Black moved the board go into closed session for the discussion of limited personnel matters under the provisions of section 10-15-1-H (2) of New Mexico Statutes Annotated 1978. Mr. Glenn seconded the motion. The roll call vote was as follows: Mr. Baeza – yes; Mr. Williams – yes; Mr. Black – yes; Mrs. Vinson – yes; Mr. Glenn – yes; and Ms. Chappelle – yes.

Upon re-convening in open meeting, Ms. Chappelle stated that the matters discussed in the closed meeting were limited only to those specified in the motion for closure.

Upon a motion by Mrs. Vinson, seconded by Mr. Glenn, the board meeting adjourned at 3:30 pm.

RE: Expenditure and Revenue Reports for November

---

November is month five or 42 percent of the 2016/2017 fiscal year. The expenditure report reflects expenditure totals that include funds expended and encumbered. The total year-to-date funds expended and/or encumbered through November 2016 is \$23,717,071.00.

Looking at the expense report for November, the Total Current Unrestricted Funds year-to-date is \$11,803,990.00 or 45% of the budget. As you compare this total to the November expenditures in 2015, the trends are similar. Instruction and General is on track for the amount of expenditures for the first five months of the fiscal year. In the other unrestricted funds, Internal Services is currently over budget because of the maintenance agreements that are paid for at the beginning of the fiscal year. Internal Services is the Computer Services Department and the Document Center. As we have indicated in the past there is a credit posted each month to the Computer Services Department to cover the cost of Computer Services from Instruction and General. As the year progresses, the monthly credit will bring the expenditures back in line with the budget for the year. Looking at the other current unrestricted departments most is consistent with the prior years. Auxiliary Enterprises expenditures are higher than the expenditures of FY 16, Robert Adams is doing a great job of making sure the right books and the right amount of books are on the shelf for the NMJC students as well as for the dual credit students up and down the County.

In the restricted funds, Grant spending is at 29% of the budget, there is a large difference between November of 2015 and November of 2016. Most of the difference is in the TAACCCT grant, as that grant is ending its cycle there are less funds to expend. Restricted Student Aid expenditures are higher in 2016 as compared to 2015. This would indicate that more students are being awarded Pell funds than in 2015. Total expenditures for restricted funds are \$2,717,018.00.

Plant fund expenditures for the month are \$92,312.00; the total year-to-date including encumbrances is \$9,196,063.00. The expenditures for the month are mostly from Campus Security, Technology Upgrades, Dorm Refurbishing, and the Entertainment

Technology project. Also, the Health, Wellness, Learning Center project is encumbered for the GOB funds and the STB funds is the design part of the Allied Health Building.

Total expenditures and encumbrances through November 2016 is \$23,717,082.00, which is 47% of the budget.

The Revenue remains positive for the fiscal year of 2016/17, even though the State funding has been cut by 5%. The 5% cut will be reflected in the reports for December. To date there are two months of Oil and Gas revenue history and the trend is steady. The outlook for funding from Oil and Gas mill levy for the rest of the fiscal year is looking positive. Auxiliary Enterprises revenue is at 57% of the budget as of the end of November. The revenue for the restricted funds has declined with the TAACCCT grant agreement coming to the end of its contract. The restricted financial aid revenue is higher in FY 17 as compared to last year, which is positive.

The year-to-date Revenue for November 2016 is \$12,598,819.00.

The Oil and Gas report shows the actual Oil and Gas revenue for July and August, and the accrual of \$465,000.00 per month for September, October and November. The first two months of actual Oil and Gas revenue is \$407,419.00 over budget. Additionally, we received \$29,094.07 in November for Oil and Gas Equipment Tax revenue. Lastly, the College received \$108,199.95 in mill levy property tax and \$14,686.46 for delinquent mill levy property tax in November. The College should be receiving a large distribution of mill levy property tax revenue from the Lea County Treasurer in December.

The Investment report reflects the \$10,593,127.00 invested with LGIP. Interest income for the LGIP funds for the month of November is \$4,092.00.

Board members please know that the full time employees across campus appreciate the December one-time allocation, we all are so grateful for the support that you as the New Mexico Junior College Board give to the faculty and staff. Thank you!

PUBLIC NOTICE IS HEREBY GIVEN that a New Mexico Junior College Board election shall be held in one of the seven voting districts, Lea County, New Mexico, on Tuesday, the 7th day of March, 2017 at which time there shall be submitted for vote to the qualified, registered elector of the District, the following matter:

**The term of office for one board position on the New Mexico Junior College Board shall expire on March 31, 2017. It is necessary that an election take place to fill this position. The term of office for District 4 Board Member is six years.**

The poll for said election will be opened at 7:00 a.m. on the day of said election and will be closed at 7:00 p.m. Precincts shall be consolidated for this election. The polling place for the consolidated precincts (such polling place being located within the consolidated precinct) is as follows:

A map of the district is available for inspection at the President's Office, New Mexico Junior College or in the office of the County Clerk.

Each voter shall cast his or her ballot in the precinct and district for which he or she resides and is currently registered and for the candidate of that district.

Residents of the New Mexico Junior College District living in the above district who are qualified electors of the State of New Mexico, shall be eligible to become a candidate to serve as a member of the New Mexico Junior College Board and shall file a declaration of candidacy on the form prescribed by law for the district in which they reside with the County Clerk of Lea County, Lea County Courthouse, Lovington, New Mexico on the 48th day before the election, January 18, 2017, commencing at 9:00 a.m. and ending at 5:00 p.m. on the same day.

No ballot on the Board Member election shall be received by any polling place board unless the person offering to vote is a registered, qualified elector of the District.
