If the Third Party Documentation is a letter from a professional (example – doctor, pastor, lawyer, etc.) it must to be on letterhead and signed with a wet signature.

_____ **Time Frame for Financial Aid Programs** – Appeal for extension of the 150% time frame limit for financial aid. You have exceeded the time frame limit of attempted credit hours without receiving an Associate’s Degree OR are unable to complete your degree at NMJC before reaching the 150% timeframe OR you are requesting to be considered for aid for a second Associate’s Degree.

Please attach:

- A typed letter of appeal that describes why you did not accomplish an Associate’s Degree within the 150% timeframe, including extenuating circumstances that impacted your academic progress OR if appeal is for aid for second Associate’s Degree, a letter describing why you are seeking aid for a second Associate’s Degree instead of continuing on to pursue a Bachelor’s Degree.

- If requesting approval for aid for a second Associate's degree, provide proof of the degree (official college transcript on file with the Registrar's office) or have an awarded NMJC Associate's Degree on file.
- You are required to see an advisor to obtain a signed degree plan of the Associate's Degree you are seeking at NMJC, outlining the courses you have completed toward your degree and the courses still needed to complete your degree. Submit the original signed degree plan with this appeal, but retain a copy for your records.
- In addition to this appeal form and letter of appeal, you *must* submit (if applicable) documentation from an objective third party professional to support your appeal letter, if you have cited extenuating circumstances to be the reason you have not completed your Associate's Degree within the required timeframe. Examples of an objective third party professional include: physician, medical records, counselor, lawyer, social worker, teacher, religious leader, birth certificate, death certificate, divorce decree, etc. *Please note that family members, friends, and NMJC employees are not considered an acceptable third party. If the Third Party Documentation is a letter from a professional (example – doctor, pastor, lawyer, etc.) it must be on letterhead and signed.
