- Pre-Assessment is mandatory for all applicants to attend, and will occur **the week of January 5th, 2026.**
- Pre-Assessment dates and times will be assigned to each applicant/agency prior to the event.
- Applicants who do not pass the mandatory Pre-Assessment may re-apply for the next available academy class.
- Applicants who have passed the mandatory Pre-Assessment, and submitted a complete application packet, will be accepted into the current academy class, **pending NMLEA approval.**
- Once accepted, all cadets are required to stay in the Bob Moran Cadet Barracks throughout the duration of the academy session.
- All applicants must resolve any outstanding debts/balances they owe to the NMJC prior to the academy start date.

Completed application packets must arrive to our office no later than December 15th, 2025.

A complete application packet must be received and reviewed by SNMLEA staff prior to the applicant's scheduled Pre-Assessment date.

If a complete application packet has *not* been received by the deadline stated above, the applicant's spot will be void from the current roster and they will be able to apply for the next available academy class.
