- Complete registration forms and application packets do not need to be turned in at the same time.
- Pre-Assessment is mandatory for all applicants to attend, and will occur the week of January 4<sup>th</sup>, 2026.
- Pre-Assessment dates will be assigned to each applicant/agency prior to the event.
- Applicants who do not pass the mandatory Pre-Assessment may re-apply for the next available academy class.
- Applicants who have passed the mandatory Pre-Assessment, and submitted a complete application packet, will be accepted into the current academy class, *pending NMLEA approval*.
- Once accepted, all cadets are required to stay in the SNMLEA Cadet Barracks throughout the duration of the academy session.
- All applicants must resolve any outstanding debts/balances owed to the NMJC prior to the academy start date.

**Completed application packets must be received no later than December 14<sup>th</sup>, 2026.**

A complete application packet must be received and reviewed by SNMLEA staff prior to an applicant's scheduled Pre-Assessment date.

**If a complete application packet has *not* been received by the deadline stated above, the applicant's spot will be void from the current roster and they will be able to apply for the next available academy class.**
